Section 2. Notwithstanding the language set forth in Section One, nothing contained therein shall preclude Washington County taxing and assessing administrators to bring the City's levy in compliance with any constitutional or statutory requirement.

Section 3. The Clerk, should be, and is hereby, directed to forward a copy of this resolution to the Washington County Clerk for delivery to the Washington County Quorum Court to assist in its deliberations at its November 2019 meeting.
