AN ORDINANCE TO AMEND THE CONVENIENCE FEE FOR CREDIT CARD PAYMENTS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PRAIRIE GROVE, ARKANSAS, THAT:

Section One: <u>Title.</u> This Ordinance shall be known as the Convenience Fee Amendment of 2019.

Section Two: Section 10.12.01(L) Amended. Section 10.12.01 (L) to the Prairie Grove Municipal Code is hereby amended to read as follows:

Convenience fee All persons paying their water and/or sewer bills through the internet or by credit card shall be assessed a convenience fee of \$0.50 plus 0.75% of the amount of the bill, in addition to all other charges, fees and taxes, to cover the costs of the payment processing center.

Section Three: Effective Date. This Ordinance shall become effective from and after 60 days of its posting unless an Emergency Clause is affixed hereto.

Section Four: Repealing Clause. Ordinances or parts thereof in force at the time that this ordinance shall take effect that are in conflict herewith, are hereby repealed.

<u>Section Five:</u> <u>Saving Clause.</u> Nothing herein shall be deemed to affect any rights or obligations existing at the time of the passage of this ordinance.

<u>Section Six:</u> <u>Severability Clause.</u> In the event any portion of this ordinance is declared inoperative or invalid as a result of a statute or judicial decision, then only that portion expressly so declared to be inoperative or invalid shall be affected thereby and all other provisions hereof shall remain in full force and effect.

Section Seven: Emergency Clause. The City Council finds that the City has been able to negotiate payment processing rates to reduce the costs citizens pay when paying utility bills electronically, and that is no reason to delay the implementation of this Ordinance immediately.

AN ORDINANCE TO APPROVE THE PRELIMINARY PLAT OF THE SYNDER GROVE SUBDIVISION, PHASES 2, 3 & 4.

Section One: Title. This Ordinance shall be known as the Synder Grove Phases 2, 3 & 4 Preliminary Plat Approval Ordinance

Section Two: Preliminary Plat Approved. The Preliminary Plat of the Synder Grove Subdivision, Phases 2, 3 & 4, as submitted by the developer and approved by the Prairie Grove Planning Commission, is hereby approved and the Mayor and Clerk are authorized to affix their names and the seal of the City thereto.

<u>Section Three:</u> <u>Installation of Improvements Authorized</u>. The developer is hereby authorized to begin installation of necessary improvements and prepare a final plat upon completion

<u>Section Four: Effective Date.</u> This Ordinance shall become effective from and after 60 days of its passage.

<u>Section Five:</u> <u>Repealing Clause.</u> Ordinances or parts thereof in force at the time that this ordinance shall take effect that are in conflict herewith, are hereby repealed.

<u>Section Six:</u> <u>Saving Clause.</u> Nothing herein shall be deemed to affect any rights or obligations existing at the time of the passage of this ordinance.

Section Seven: Severability Clause. In the event any portion of this ordinance is declared inoperative or invalid as a result of a statute or judicial decision, then only that portion expressly so declared to be inoperative or invalid

shall be affected thereby and all other provisions hereof shall remain in full force and effect.
